# OUTDOOR EQUITY FUND 2024 PROGRAM GUIDE

## INTRODUCTION

The Outdoor Recreation Division (ORD) increases equitable access to the outdoors for all New Mexicans, ensuring healthy outcomes, environmental stewardship, and economic prosperity.

Access to the outdoors is a basic human right – yet it's one that has often been denied to many of our youth. As a result, our underrepresented kids haven't had the chance to experience some of the best of New Mexico: Its outside world.

The Outdoor Equity Fund (OEF) was created to ensure equitable access to the outdoors for all youth. The grant supports transformative outdoor experiences that foster stewardship and respect for New Mexico's lands, waters, and cultural heritage.

This program guide is intended as a tool for applicants to the 2024 Outdoor Equity Fund. It breaks down specific requirements and provides examples for success, as well as contact info for ORD staff. Grant History:

- In 2020, OEF opened for the first time, awarding 25 New Mexico organizations over \$270,000.
- In 2021, ORD awarded almost \$900,000 to 57 applicants, to get more than 22,000 young New Mexicans outside.
- In 2022, OEF awardees totaled 48 entities with over \$800,000 benefitting 12,391 kids.
- In 2023, ORD awarded a record \$3.7M to 113 programs.

# **GRANT OVERVIEW**

General Eligibility Requirements	<ul> <li>Eligible Applicants: Tribes, Pueblos, and Nations; municipalities; counties; nonprofits; K-12 schools/districts; colleges/universities.</li> <li>Recreation Access: Applicant must have a well-developed written plan to engage youth in nature-based outdoor recreation activities.</li> <li>Participants: Serve a population where at least 40% are low-income youth up to age 18.</li> <li>Education: Applicant must include some type of education plan on the climate and environment.</li> </ul>
2024 Grant Cycle	Grant opens July 1, 2024. Applications accepted through August 31, 2024.
Deadline	August 31, 2024.
Award Range	\$5,000 - \$40,000
Match Requirement	<ul> <li>Required 2:1 match. The match can include any combination of cash and/or in-kind (See FAQ page 8 for more details).</li> <li>NO match required if you meet any one of the below criteria: <ol> <li>Tribal community – qualify for match waiver if a tribe, pueblo, or nation is the direct applicant, or if you are a non-profit, school, etc. located on a tribe, pueblo, or nation and serving Indigenous youth;</li> <li>Rural community – "Rural" is defined as any part of the state other than Los Alamos County, Albuquerque, Rio Rancho, Farmington, Las Cruces, Roswell, Santa Fe, and within a 10-mile radius around those cities;</li> <li>BIPOC lead organization serving BIPOC youth;</li> <li>Tell us your story – if you are concerned about meeting the match requirement and do not meet any of the above criteria but are serving a community that has historically had limited access to the outdoors you may still qualify for a match waiver.</li> </ol> </li> </ul>
Contract and Reporting Requirements	<ul> <li>Program must be completed within 18 months of the signed contract date.</li> <li>Grant money will be paid in full up front after grant agreement signing.</li> <li>Applicant must submit either one progress report, complete one site visit, or have one progress phone call as well as submit one final report after the completion of the program.</li> <li>Applicant must submit photos and be willing to participate in marketing and promotional efforts.</li> <li>Grants will be split between tribal, rural, acequia/land grant, and urban communities.</li> <li>Each awardee is required to tag ORD (@NMOutdoorRec) in at least one social media post or mention ORD/OEF with a link to the ORD website (NMOutside.com) within 18 months of the signed contract date.</li> </ul>

## ELIGIBLE OUTDOOR RECREATION ACTIVITIES

How we define outdoor recreation: Any activity that takes place outside, in a natural environment.

#### Examples of activities include, but are not limited to:



Adaptive outdoor recreation of all types



Camping: tent, RV, yurts, etc.



Trail activities: hiking, backpacking, trail running, horseback riding, hunting etc.



Off-road motorized activities: UTV, ATV, off-road motorcycles, etc.



Nature enjoyment: wildlife viewing, wildlife photography, birdwatching, nature walks, plant identification, etc.



Bicycling: road, mountain, gravel, bikepacking, etc.



Water activities: canoeing, kayaking, rafting, stand-up paddle boarding, fishing, etc.



Snow activities: snowboarding, all skiing types, snowshoeing, etc.

### **EXAMPLES OF SUCCESS**

Meet a few past Outdoor Equity Fund awardees

Awardee: Friends of Organ Mountains-Desert Peaks Award: \$20,000 Location: Las Cruces Description: The Moving Montañas initiative connects youth to the outdoors through guided hikes, summer camps, camping trips, and other educational enrichment activities. It aims to educate users about the impacts of a changing climate on the Chihuahuan desert and the actions they can take to help solve our climate crisis.





Awardee: Zuni Youth Enrichment Project (ZYEP) Award: \$20,000

Location: Zuni Pueblo

**Description:** ZYEP recognizes the importance and impact of connecting Indigenous youth to culturally significant ancestral sites and how that can contribute promoting resilience in Zuni youth so that they grow into strong and healthy adults who are connected to their culture. The project will facilitate outdoor retreats that allow youth to visit ancestral sites from their migration story, while participating in outdoor recreational activities that are available at those sites.

Applicant: Global Opportunities Unlimited Inc. Award: \$7,700 Location: Albuquerque

**Description:** Provides inclusive educational fishing and watershed education for disabled, disadvantaged, and low-income children, using adaptive technology to expand the availability of outdoor opportunities to people with disabilities. Participants will learn about aquatic ecosystems and the effects of climate change.



### FAQS

#### How is "rural" defined for the match?

"Rural" is defined as any part of the state other than Los Alamos County, Albuquerque, Rio Rancho, Farmington, Las Cruces, Roswell, Santa Fe, and a 10-mile radius around those cities.

#### How does my organization qualify for NO match requirements?

By meeting any one of the following criteria (see also page 4) as (1) a Tribal community (tribe, pueblo, or nation) OR are located on a tribe, pueblo, or nation, serving Indigenous youth; (2) a rural community (any part of the state other than Los Alamos County, Albuquerque, Rio Rancho, Farmington, Las Cruces, Roswell, Santa Fe, and within a 10-mile radius around those cities); or (3) a BIPOC lead organization serving BIPOC youth.

#### Does the match requirement have to be cash?

No. The match component can be any combination of cash or in-kind (i.e. volunteer hours or donated equipment, services, or materials). Some other state grants and federal grants can also be used as a match.

#### Are privately owned businesses or state agencies eligible to apply?

No. Neither privately owned businesses / organizations nor state agencies are eligible to apply. Only the following entities are eligible: Tribes, Pueblos, and Nations municipalities; counties; nonprofits; K-12 schools/districts; colleges/universities. However, private businesses can be OEF Ambassadors in support of the Outdoor Equity Fund.

#### Can my organization submit more than one application?

No. Only one submission per entity is allowed per year. Please do not submit multiple applications from different partners for the same program (in an attempt to increase the odds of it being funded). In this case, submit one application for the program, and include letters of support from your partners.

#### When can I expect to hear back about my application?

Applications will be reviewed by a volunteer committee, with reviews scheduled in the month following application closure. You will typically receive an email from the ORD team within a month of each review period to inform you whether your program was awarded funding. BOTH those awarded and denied funding will receive an email.

#### What are the requirements if I receive a grant?

Program must be completed within 18 months of the signed contract date. The applicant adhering to a template created by ORD - must submit (1) progress report, complete (1) site visit, or have (1) progress phone call halfway through the grant period, AND (1) final report after the completion of the program. The applicant must submit photos and be willing to participate in marketing and promotional efforts. Each awardee is required to tag ORD (@NMOutdoorRec) in at least one social media post or mention ORD/OEF with a link to the ORD website (NMOutside.com) within this reporting time frame. Additional OEF/ORD mentions and promotion is encouraged and will be reciprocated.

## **APPLICATION TIPS**

- For more information and to access the application, visit the <u>New Mexico Outdoor</u> <u>Recreation Division website.</u>
- Be concise with responses; there is a word limit for each question. You will be prevented from submitting if any answer exceeds this limit.
- Pay close attention to additional instructions in the application notes. Some requirements, if not completed correctly, will disqualify you from receiving funding or significantly delay the funding process.
- Double-check the award amount, budget, and match to ensure they are accurate.
- Confirm the account the application is submitted from is the primary contact. ORD will send all grant updates to the account that submitted the application for the entire duration of the 18-month grant contract and the application process.
- Save your work in the online application frequently. Connection errors can lead to a loss of data that is not recoverable. Do not rely on autosave.
- Take advantage of the "Collaboration" option in the online application. This allows organizations to select multiple users to work on a submission. This will appear in the top right-hand corner of the page after you log in to your account.
- To avoid technical difficulties, submit early. If you do run into technical issues with login, application, or submission, contact Submittable <u>here</u>.
